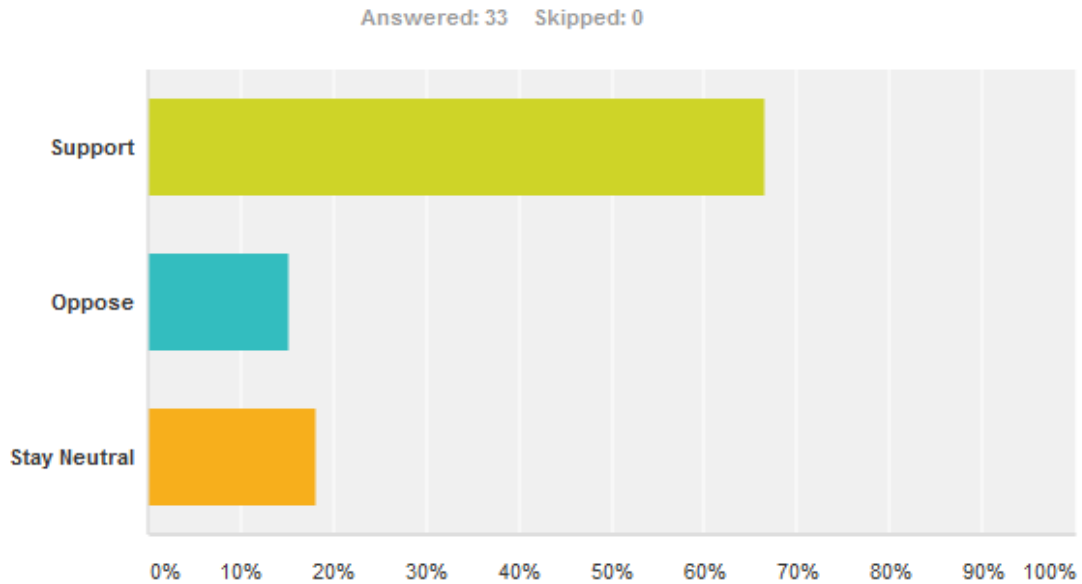


Question 1:

Senate Bill 1184 (Wagner) – Senate State Government Committee

This bill amends a section of the lobbyist disclosure act to note that the cost of a reception attended by a state official or an employee in connection with public office or employment shall not be considered something of value for the purpose of reporting.

Do you think PAGR should:



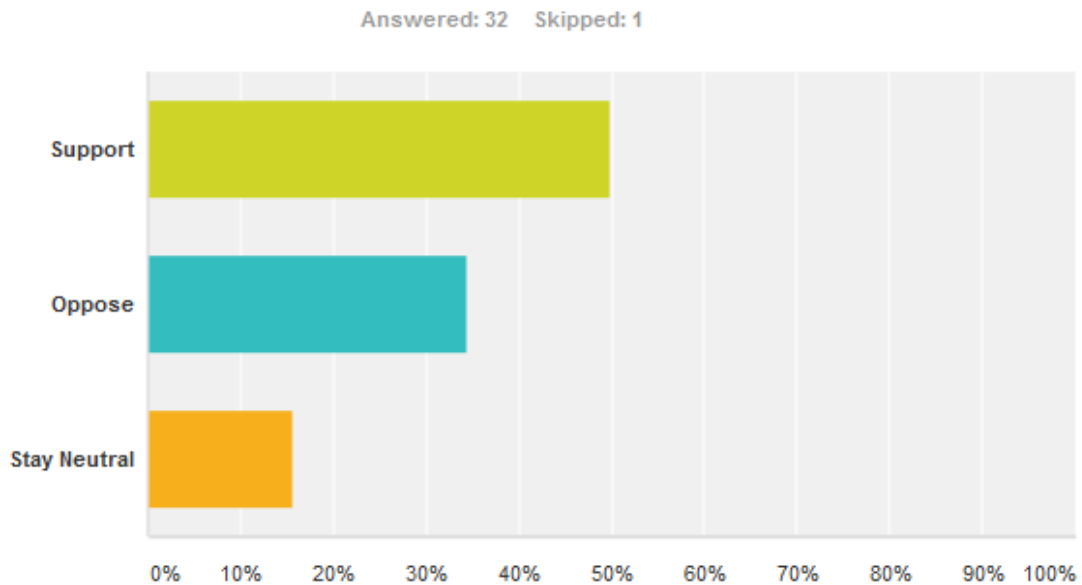

Question 2:

Senate Bill 1185 (Wagner) – Senate State Government Committee

This bill amends the definition of “lobbying” to include the “representing a membership organization.” PAGR has confirmed that this amended definition is intended as a catch-all to capture membership organizations whose executive staff may not be registering but are working to supplement the efforts of their designated government relations staff. PAGR believes that the current system is capable of handling these additional registrations.

Question 3:

SB 1187 (Eichelberger) – Senate State Government Committee

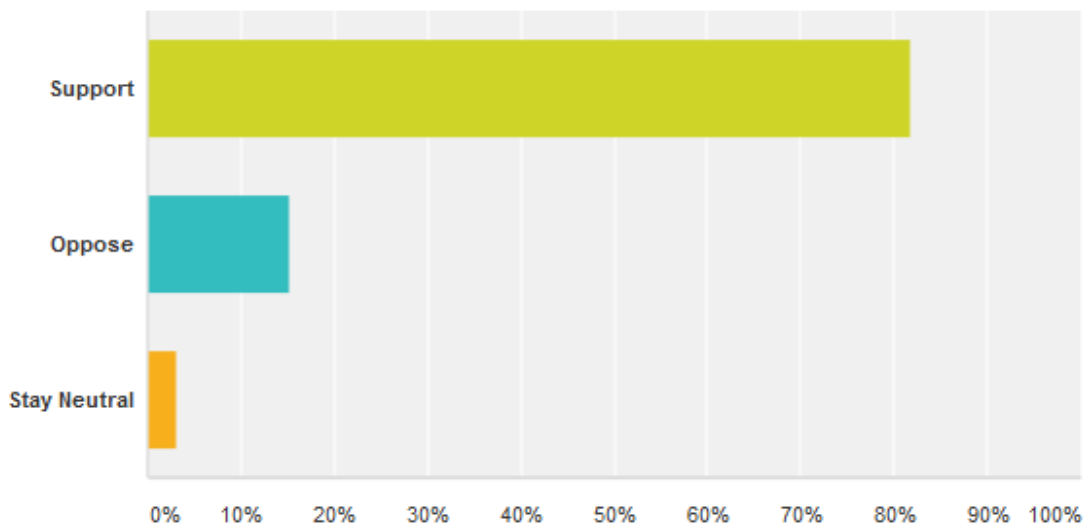
This bill would prohibit a lobbyist from doing campaign work for statewide offices or the General Assembly in the following capacities:

- Serving as a chairperson or treasurer (or any other officer required to be included on a political action committee registration) for a candidate’s PAC.
- Owning, being a partner in, or serving as an officer or board member of any business or association that receives compensation for campaign work.
- Doing paid work on a campaign for statewide seat or a seat in the General Assembly.

PAGR understands that this issue has become especially timely in light of the recent FBI sting. For that reason, additional comments supporting your position on the issue are especially important.

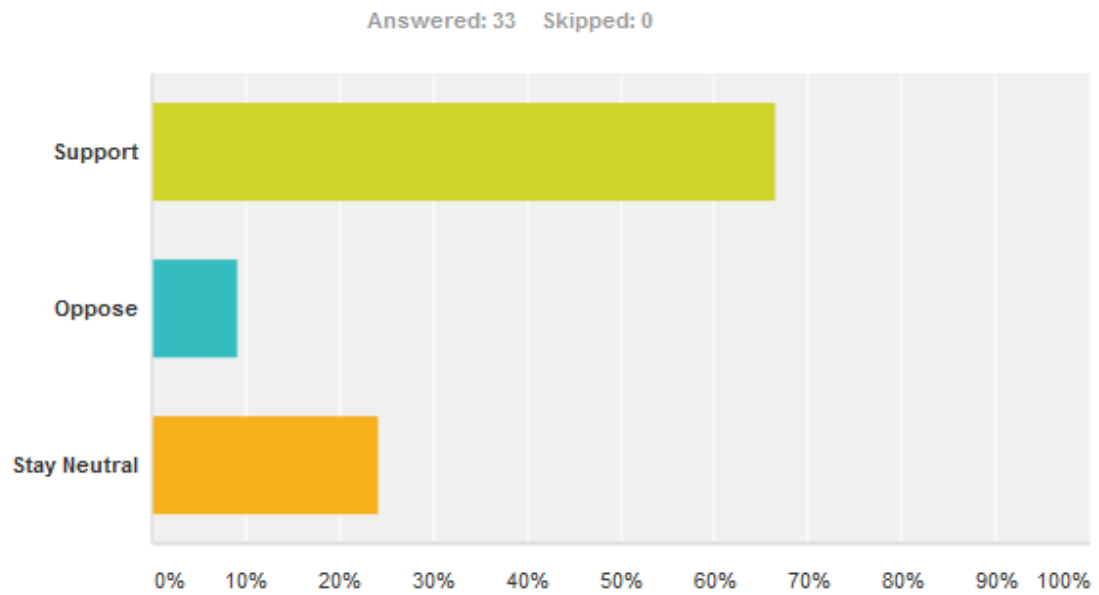

Question 4:

SB 1188 (Aument) – Senate State Government Committee

This bill would require anyone that must file a Statement of Financial Interest to disclose any immediate family member of theirs that is require to register under the Lobbying Disclosure Law and vice versa.

Do you think PAGR should:



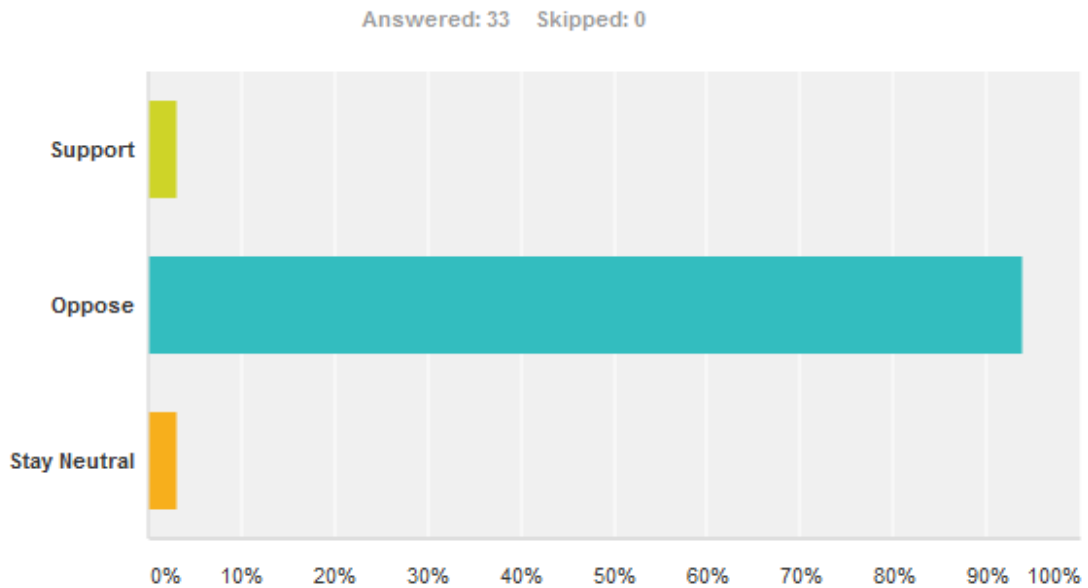

Question 5:

SB 1189 (Reschenthaler) – Senate State Government Committee

This bill would increase the penalties for violations of the lobbyist law from \$2,000 to \$4,000 with penalties increasing for repeat violations. PAGR fundamentally opposes this bill, as the current lobbyist reporting system is ill-equipped to timely process and publish registration, compliance of which is not the fault of the registering lobbyist.

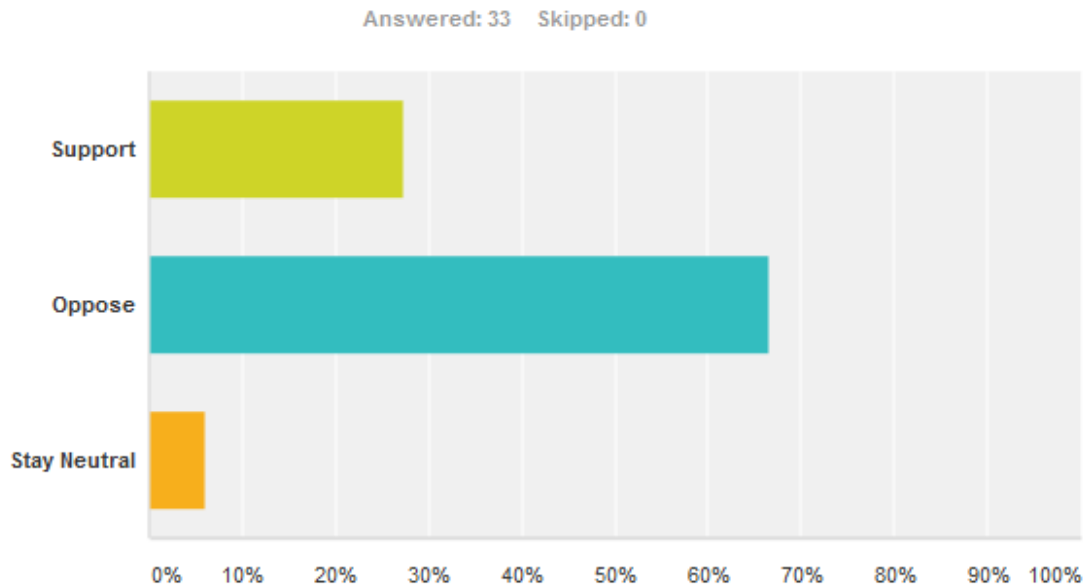

Question 6:

SB 695 (Scarnati) – House State Government Committee

This bill would require all lobbying registrations to be done electronically. Additionally, the bill would require the Department of State to publish all filings within seven days of receiving the registration. PAGR has serious concerns regarding the current system and its accuracy insofar as the ability of the system to comply with such a mandate.

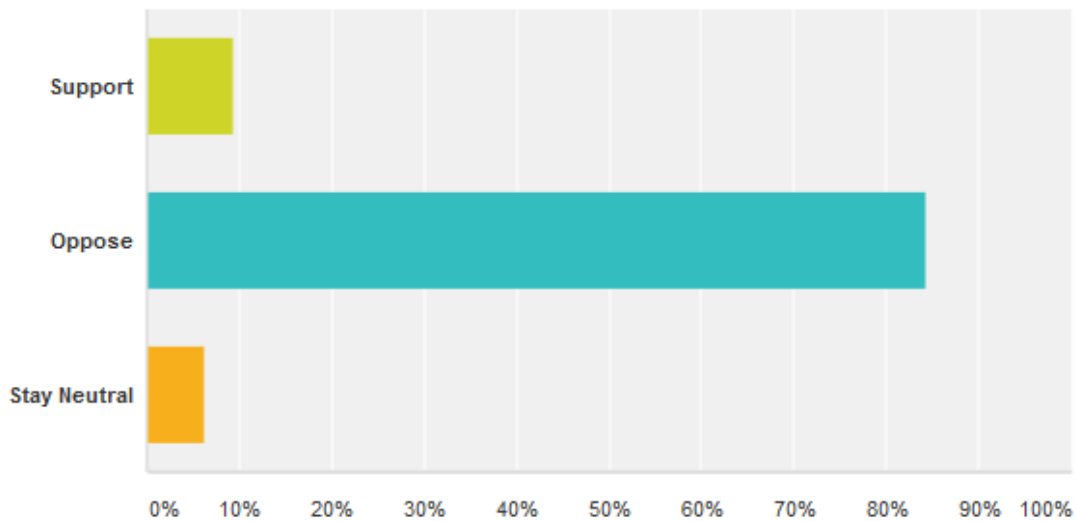
Question 7:

HB 1348 (Cutler) – Senate State Government Committee

This bill would increase the fines associated with simple noncompliance from \$2,000 to \$4,000 for negligent failure to file or report. It would also increase the fine for negligent failure to register or report from \$50 for each day late to \$100 for each day late between 10-19 days and \$200 a day after 20 days late. As is the case with the Scarnati bill, SB 695, PAGR has serious concerns regarding the current system and its accuracy insofar as the ability of the system to comply with such a mandate.
